Update on Software License sales 2022 Financial Year to-date

22 February 2022

RPMGlobal Holdings Limited (ASX: RUL) [RPM®] is pleased to provide the following update on Software License sales concluded since 1 July 2021.

Total Contracted Value (TCV) derived from software license sales year-to-date is \$31.0m an increase of \$5.5m from RPM's half-year results announcement to the market on 21 February 2022 (\$25.5m). Included in this year-to-date number is \$1.4m from perpetual license contracts.

RPM now has \$81.1m in pre-contracted noncancellable software subscription revenue, which will be recognised in future years.

RPM's ARR from software subscriptions (excluding annually recurring maintenance and support revenue from past perpetual software licenses) has increased by \$1.4m from the 1st of January 2022 and now sits at \$27.9m.
