## Update on Software License sales 2022 Financial Year to-date

10 May 2022

RPMGlobal Holdings Limited (ASX: RUL) [RPM®] is pleased to provide the following update on Software License sales concluded since 1 July 2021.

RPM's ARR from software subscriptions (excluding annually recurring maintenance and support revenue from past perpetual software licenses) has increased by \$2.1m from 22 February 2022 and now sits at \$30.0m.

Total Contracted Value (TCV) derived from software license sales year-to-date is \$40.5m an increase of \$9.5m from RPM's announcement to the market on 22 February 2022 (\$31.0m). Included in this year-to-date number is \$1.6m from perpetual license contracts.

RPM now has \$85.8m in pre-contracted noncancellable software subscription revenue, which will be recognised in future years.
