Correction - Update on Software License sales 2022 Financial Year to-date

27 June 2022

RPMGlobal Holdings Limited (ASX: RUL) [RPM®], provides the following **correction** to the previous announcement lodged this morning on the Software License sales concluded since 1 July 2021. The previous announcement inadvertently recorded the comparison TCV number from 14 June 2022 as \$47.1m (the correct comparative number is \$47.4m) and the increase in TCV as \$3.2m (the correct number is \$2.9m). The complete corrected release is as follows:

RPMGlobal Holdings Limited (ASX: RUL) [RPM®], is pleased to provide the following update on Software License sales concluded since 1 July 2021.

Total Contracted Value (TCV) derived from software license sales year-to-date has broken through the \$50m barrier and now sits at \$50.3m an increase of \$2.9m from RPM's last announcement to the market just under two weeks ago on 14 June 2022 of \$47.4m. Included in this year-to-date number is \$1.7m from perpetual license contracts.

RPM's ARR from software subscriptions (excluding annually recurring maintenance and support revenue from past perpetual software licenses) has increased over the last two weeks by \$0.5m and now sits at \$31.6m.

RPM now has \$90.0m in pre-contracted non-cancellable software subscription revenue, which will be recognised in future years.
